

Authorized Waiting List of Owners Who Wish to Lease Their Properties

Andalusia HOA currently restricts the leasing of units until such time as the total number of leased units in the complex are **no greater than 26 (25% of 104 owned units)** as required by California State regulations. The CCRs for Andalusia HOA limit to 20%, or 21 owned units as defined in the "First Amendment to Andalusia Amended and Restated Declaration Establishing A Plan for Condominium Ownership", Section 7.19 B. (3). *State regulations take precedence.*

The following owners have asked to be placed on this waiting list and have been approved by the Board of Directors. Owners who wish to be placed on this List must attend a regularly scheduled Board Meeting for approval. Furthermore, owners who are offered leasing understand **without exception** that they have:

#1 **Three weeks** to decide to make the decision to lease.

#2 **Six months** from the decision to lease to lease their unit.

#3 **No extensions of time beyond six months will be considered for any reason, including but not limited to school considerations.**

#4 At the end of six months, if a lease is not executed, the offer to lease will be rescinded, and the owner placed back on the Lease Waiting List in the last place position on the List.

The following is the order in which conversion requests from owner occupied to lease units will be considered:
